

- 5. Though, name of petitioner's college shall be shown for granting seats, but no students shall be allotted to the petitioner's college without the leave of the Court.
- 6. Petitioners' request for issuing interim direction for giving admission to the students and/or appropriate interim relief shall be considered on the next date.
