- 2. Candidates required to fill application form must deposit non-refundable application fee of INR 2000/- (INR 1200/- for SC, ST, ST-STA category candidate of Rajasthan state domicile as well as candidate of Rajasthan state domicile whose family annual income is less than INR 2.5 lacs) + applicable transaction charges.
- 3. The candidates are advised to visit these websites regularly for all relevant information.
- 4. All registered candidates who are eligible and wish to participate in stray vacancy round II off-line counseling must present themselves personally before the Board on the designated place, date and time. To participate, print 'Entry Ticket' through candidate's login and carry the same.
- 5. A candidate allotted a seat in stray vacancy round II does not join the allotted seat shall be debarred from participating in the State counseling process for next one year, alongwith forfeiture of security amount.
- 6. No candidate will be allowed to resign from the State Quota seats after joining in round 3 as well as in stray vacancy round or having status as 'Joined'.

7. **Submission of original documents:** All candidates who wish to participate in stray vacancy round II off-line counseling must bring all the original documents and undertaking (as given in the instruction booklet available at the website).

In stray vacancy round II off-line counseling, a candidate who gets allotment shall deposit his/her original document alongwith undertaking.

8. Eligibility

- Round 3 allotted / upgraded candidate is not eligible to participate in stray vacancy round II.
- Stray vacancy round II candidate allotted a seat on 27.09.2023 or 29.09.2023 (MBBS / BDS course) is not eligible to participate in stray vacancy round II.
- A candidate who has already joined a seat allotted through Rajasthan state counselling / any other state counselling including all India counselling is not eligible to participate in stray vacancy round II.
